Ceil spent her childhood in Wheeling West Virginia and boasted about her perfect attendance in school in spite of snowy winters. Following high school graduation she attended a local secretarial school and took her first job as secretary to an accountant.

During WWII, Ceil's next-door neighbor, befriended a nice Greek boy while serving in Alaska. He encouraged Jim to write to this cute little Greek girl back home whom he could never date himself, being non-Greek. Thus began a three-year pen-pal courtship between Ceil and Jim. They were married in Dallas, Texas in 1945 and returned to Oakland to build their family and grocery business. Ceil and Jim were blessed with three children, MaryAnn, Theodora and Paul.

For 25 years, Ceil held secretarial positions for the East Bay Regional Parks District. Ceil and Jim were active members of the Oakland Greek Orthodox community. Ceil was a 65 year member of the Daughters of Penelope of the American Hellenic Educational Progressive Association.


