



AHEPA Campaign to Build Saint Nicholas National Shrine at World Trade Center

September 11 was a national tragedy that forever changed America. Nearly 3,000 lives were lost; 39 of who were Greek Americans. Also lost that fateful day was the only House of Worship destroyed by the 9/11 attacks Saint Nicholas Greek Orthodox Church.

The effort to rebuild Saint Nicholas was mired in bureaucracy. AHEPA's "Cut the Red Tape!"" campaign proved effective in helping to budge the bureaucracy of the New York/New Jersey Port Authority to allow for the construction of Saint Nicholas at Ground Zero.

Now the time has come to build the Saint Nicholas National Shrine at World Trade Center. AHEPA and its affiliated organizations, the Daughters of Penelope, Sons of Pericles, and Maids of Athena, will support the campaign to build the Saint Nicholas National Shrine by raising funds during the next two years.

Greek family for always pushing her to success. She has the upmost respect for her "hero", her Yiayia.





His essay mentions his desire to be a criminal defense attorney and, importantly, "to give back to the community at large" by giving a voice to those who may not have the opportunity to legally defend themselves. His first reference letter from his football coach at Lake Forest Academy notes Chris being a true leader and "role model for his fellow classmates …and also possesses many intangibles you can't coach". His second reference letter from a family attorney mentions him being "a true gentleman

with an inquiring mind, and graciousness."

Angeliki Marina Menig (Bundros) attends San Jose State University for an M.S. degree in Occupational Therapy. Her major is Neurobiology & Psychology with a GPA of 4.0. She completed a dual BA at UC-Davis. Angeliki's goal is pediatric O.T. professional (and researcher); she is well on her way. Angeliki is on the Dean's List, O.T. His bio statement and list of numerous activities he's involved with which offer us a well-rounded view of Jonathan. With a GPA of 3.32 and two solid reference letters he seems well prepared for the next life chapter with a career goal of becoming a physician. One reference mentions Jonathan's "superior analytical skills and sincere desire to learn", while the second letter from a Pediatric Physician (with whom he volunteered) makes note of Jonathan's calming demeanor with child patients (a real skill), his maturity, and deep empathy.

mentions her strong abilities for teaching art at a non-profit, and her "good sense of the commitment and energy required..." to engage children's learning...!believe that she will excel."

She wishes to complete a B.S. degree in Engineering at Seattle Pacific University (Seattle, Washington). Leslie received the AP Scholar Award, is a member of Valley Church Youth Group, tutors children in math and English, participates in the Marching Band, and is an active member of the California Scholarship Federation (for four years). A reference letter from her English/Journalism teacher notes that Leslie "has proven to be one of the most focused and determined students I have ever witnessed"... is "a brilliant writer". The teacher uses Leslie's essays to show to future classes in her teaching. The second reference letter notes "Leslie is a joy to be around...cheerful, thoughtful, encouraging ..." and "serves as an example

to others as to how to engage."

Marissa Mullins is a High School student at San Rafael and seeks a BS degree in a medical field (undetermined). Her bio statement conveys a warm and personal young woman with a caring focus on helping the underprivileged with healthcare needs. Her GPA is an impressive 3.9 with an ACT score of 23. Marissa received a Physics honor award, is active in track and field, Red Cross Club, and many others. She also lists participation in the National Charity League, and is a horseback rider. A reference letter from her Science Department Chair mentions Marissa's keen insights and helpfulness to other classmates. Moreover, a second reference letter from her High School Counselor mentions her solid intellectual curiosity, mature risk taking, passion for success, and calm demeanor.





Christina Tsapouklis attends Northgate High School in Walnut Creek, CA where she holds a GPA of 3.1. Her essay mentions the career goal of a Pediatric Physician/Surgeon. Most immediate is her objective to complete a BS degree in Biology at Cal State University Pomona. Her application lists several activities such as Link Crew, Lacrosse, Fashion Club, Greek dance, swim coach, and others; hence she is well rounded. One reference letter mentions her "extraordinary work ethic" and "exceptional presence and dedication towards teachers and peers ..." Another reference letter from her Pastor notes Christina's "ubiquitous passion for improving her community ...prayerful, humble attitude, a calm reserve, and leadership

ability".

Panos Constantinou is a student at ENOCH High School in Modesto where he holds a 3.4 GPA. He seeks support to attend CSU-SF for a BA degree in film with a minor in music. His school counselor writes a heartwarming reference letter, which mentions his outgoing nature, and keen interest in video arts and production. A second letter from his GOYA advisor mentions his strong leadership skills and commitment to Church and community.





Marco Petrucci attends Jesuit High School with a GPA of 3.4, and seeks to complete a BA degree in Sports Management from the University of Oregon. His school activities are diverse, ranging from varsity baseball to senior retreat team leader, senior big brother, freshman football, and VP of the Greek Club. For Church, Civic, and other activities he has been an Altar Boy since age 7, Greek dance participant, volunteer soccer coach at an elementary school, builder of homes in New Orleans, etc. Both reference letters are very positive. One letter from his Presiding Priest mentions his outstanding Greek Orthodox Christian values, and the other letter from his High School counselor notes his "strong desire to help others" in campus and in community life.

Elana McCormick attends Santa Barbara City College with an immediate goal of an AA degree focused on Psychology. Elana's personal essay mentions becoming a Master Degree prepared therapist. 
AHEPA VETERANS REGISTRATION

AHEPA Medal for Military Service is awarded to all veterans in Honor of their service to the United States.

"The Mission of the Order of AHEPA Veterans Committee is to archive and recognize all veterans of the Order and Hellenic community through sound communication and publication. Furthermore, to conduct fund raising and philanthropic outreach through a cohesive, limited, yet well defined activity that reflects well on the Order of AHEPA and brings credit to the organization at large."

The AHEPA Medal for Military Service, approved by the 106th Congress, was presented to all AHEPA veterans present at the 34th Biennial Congressional Banquet, March 29, 2000. The Supreme Lodge then encouraged its districts and chapters to present this medal to its deserving veterans unable to attend this banquet. It is this committee's intent to register AHEPA Veterans and have the AHEPA Medal presented at appropriate events at the District and Chapter levels. Funds collected through this effort cover medal production and other administrative costs to include shipping. Remaining proceeds will be donated to the Wounded Warrior Program annually.

Eligibility requirement for AHEPA Medal for Military Service includes Honorable Service and Discharge. Service includes Active Duty, National Guard, or Reserve status of the United States Armed Forces. REGISTER ONLINE AT WWW.AHEPA.ORG. File a copy with your chapter Secretary after registration is complete. Medals are normally shipped in the fall and in time for Veteran's Day celebrations in November.
