



### About Man of God

Exiled unjustly, convicted without a trial and slandered without cause, St. Nektarios of Aegina’s life was one of persecution and prosecution. A priest of the common people, St. Nektarios’s popularity provoked the jealousy of the clergy in Alexandria and, as a result, he was defrocked and expelled from Egypt. In contrast to his religious “superiors”, Nektarios cared for the poor, taught peasant girls to read and write, and performed miracles. Even his last moment on earth was used to help another: upon his death, Nektarios’ undergarment was removed, and as it fell upon a paralyzed man in the hospital bed next to him, the lame man miraculously arose to walk. Nektarios was recognized as a saint in the Eastern Orthodox Church in 1961, and his feast day is celebrated Nov. 9. The music for the film was composed by two-time French Cesar winner Zbigniew Preisner with special performance by Golden Globe winner Lisa Gerrard.

## FOR MEMBERS OF THE AHEPA FAMILY: “E” IS FOR EDUCATION

### Who is an Accredited Investor?

This is an often asked question with an actual answer. First, who asked this question and why is it asked?

Because all investors are risking a current, usually liquid asset such as cash, the expectation is a return on investment. Why demand a return on invested capital? Because inflation will erode the purchasing power of the capital – in this case, the cash capital, over time.

In usual times, unaffected by extreme politics, extreme weather or a pandemic, as examples, inflation will historically fall in the one to four percent per year range. This is measured by the C.P.I. (Consumer Price Index) calculated on a formula for a “basket of goods and services”.

For an individual investor, the goal becomes to receive after tax return that exceeds the CPI increases each year with risk held as low as possible.

In more usual times, an individual investor could buy U.S.A. Treasury bonds (up to 30 years duration) and perhaps try to exceed inflation. As an option, the investor could alternatively buy municipal bonds (MUNI bonds) that are sometimes tax free. Accordingly, these MUNI’s however pay less interest and will be more risk than U.S. Treasury bonds.

Here is where investors break into various levels or risk/reward that is unique to each individual as the finger prints on her or his hands.

Many people invest little or small sums in savings due to personal reasons. Some reasons include disability as one extreme example. Others see investing in securities as a form of gambling and refuse to invest. And still others seek high risk/high return investments.

An accredited investor falls somewhere in the middle. This person is typically an experienced investor seeking a return greater than can be received from Treasury or MUNI bonds, Corporate Bonds, Mutual Funds, ETFs and other “market” instruments such as individual stocks.

Investing is generally recognized as a highly regulated business. This regulatory environment is put in place in order to protect investors, provide transparency, and keep confidence in the U.S. financial system.

Thus, investments with higher risk, long duration, illiquidity, and needed market segment knowledge (including all of these and more) must be considered. The established rules make certain investments accessible to those investors who know what they are getting into by way of their investments.

According to Investopedia, an accredited investor is one who: Is an individual or a business entity that is allowed to trade securities that may not be registered with financial authorities such as the S.E.C. A financial professional holding a FINRA Series 7, 62, or 65 can also act as an accredited investor.

Generally the management and owners of an LLC can consist or be composed entirely of non-accredited investors, and the LLC can still be considered an accredited investor if it’s registered as the holder of the shares in the investment it is making.

The SEC defines an accredited investor as either:

1. An individual with gross income exceeding \$200,000 in each of the two most recent years or joint income with a spouse or partner exceeding \$300,000 for those years and a reasonable expectation of the same income level in the current year.
2. A person whose individual net worth, or joint net worth with that person’s spouse or partner, exceeds \$1,000,000, excluding the person’s primary residence.
3. Those with CFA and CFP designations have been considered as have licensed CPAs and attorneys.
4. Accredited investors and qualified purchasers are both allowed to purchase securities not registered with the SEC. Accredited investors can invest only in 3(c)(1) funds, whereas qualified purchasers can typically invest in both 3(c)(1) funds and 3(c)(7) funds.

Those investors who meet this minimum criteria may choose to invest in Real Estate, private com-

panies, natural resources and other offerings.

This may seem to be “un-democratic” or unfair to the small investor. The rules are set and the investment opportunities work within the framework. This is to protect the small or uneducated investor. The best result is sought for these small or inexperienced investors by fiduciaries offering the investments. Will this change in the future? There is an ongoing discussion as to keeping a balance between protecting the consumer and allowing investors more choices. Such choices are enjoyed by accredited investors today.

Who controls the investment markets such as the NYSE? There is no exact answer and some would suggest that 85% of the stock and bond trades including mutual funds and ETFs are controlled by institutional investors such as insurance companies, sovereign funds, public and private pension plans, banks, and investment companies as examples. The other 15% are individual investors. The FED (US Federal Reserve Bank) also plays a role by controlling the interest rates. Foreign currency manipulators also influence investment returns.

Question: I am an accredited investor. How much may I expect as a return on my private investment? The answer is as “clear as mud”. That is, with all reward, what is the risk that an accredited investor is willing to accept? From experience, passive returns (not active returns from buying a rental house and handling all the details by the owner) can exceed 25% per year.

This is NOT for new or inexperienced investors because there is a very real chance to lose the entire investment. There is no bank guarantee, no FDIC insurance and no loss of principal protection.

Question: So, how do I go about investing for my future? Talk to your registered investment advisor (RIA). That person is registered nationally and in each state. The RIA may review your current assets and determine a suggested fit. Ask your RIA if they are a fiduciary: a person who has taken an oath to put the interests of the client before his/her interests.

Becoming financially literate takes effort and time. This is also where your chosen RIA can be of help. Teach your children and grandchildren the independence for their future and their eventual

retirement. That is what all members of the Ahepa family can do for their own families as well as for friends and neighbors.

Question: But, what if I am already doing all that and want to get a higher than market return on my investments? I am already maxing out my 401k, IRA, and Roth IRA each year. I have confirmed my status as an accredited investor. The answer is to explore self-directed retirement and investment options. Talk with your RIA about these options that are not available to non-accredited investors.

Self-Directed accounts are administrated by a “third party administrator”. These are neutral, investment agnostic, non-advice providing record keepers that earn a quarterly fee for their work. There are numerous TPA’s across the USA and they should be dedicated to financials, not health-care for example. Your traditional RIA or IA (Investment Advisor) at a retail brokerage may not be as familiar with these TPAs or accredited private investments. Again, these investments via self-directed accounts are generally for accredited investors, only.

Question: If I have questions, who can I speak with on a confidential basis? The answer is to speak with your current RIA or a no cost or obligation consultation with an investment advisor.

## AHEPA VETERANS REGISTRATION

*AHEPA Medal for Military Service is awarded to all veterans in Honor of their service to the United States.*

“The Mission of the Order of AHEPA Veterans Committee is to archive and recognize all veterans of the Order and Hellenic community through sound communication and publication. Furthermore, to conduct fund raising and philanthropic outreach through a cohesive, limited, yet well defined activity that reflects well on the Order of AHEPA and brings credit to the organization at large.”

The AHEPA Medal for Military Service, approved by the 106th Congress, was presented to all AHEPA veterans present at the 34th Biennial Congressional Banquet, March 29, 2000. The Supreme Lodge then encouraged its districts and chapters to present this medal to its deserving veterans unable to attend this banquet. It is this committee’s intent to register AHEPA Veterans and have the AHEPA Medal presented at appropriate events at the District and Chapter levels. Funds collected through this effort cover medal production and other administrative costs to include shipping. Remaining proceeds will be donated to the Wounded Warrior Program annually.

Eligibility requirement for AHEPA Medal for Military Service includes Honorable Service and Discharge. Service includes Active Duty, National Guard, or Reserve status of the United States Armed Forces.
